### ELIGIBILITY FOR MANUFACTURER MEMBERSHIP

1. Applicant must be a producer of products associated with production, distribution, or control of fluid comfort or radiant heating and cooling.
2. Applicant must be financially sound and of good reputation.
3. Applicant must have sufficiently trained personnel to provide competent educational and technical service to its customers.
4. Applicant must be able to adequately fulfill customers needs with due consideration to the scope and character of the applicant's business, the market in which the applicant sells, and the class or classes or customers with whom the applicant does business.
5. The term "manufacturer" includes any company which fabricates or assembles standard proprietary products regularly offered for sale under the scope of 1 above.

**Dues** are an annual obligation for the calendar year and shall be calculated on the aggregate volume of domestic and international sales generated by operations within the United States for the most recently completed year of each member, its parent, divisions, affiliates and subsidiaries in the United States if representatives of these entities are to participate in the affairs of the Alliance. Dues are based upon the products falling within the scope of the RPA. Dues must be paid on an anniversary date.
